

**GENERAL INFORMATION:** **SANI-MINT** makes a clear, sparkling clean solution when mixed with water that brings the delightful fragrance of wintergreen to your cleaning duties. Use in sick rooms, nurseries, restaurants, hospitals, nursing homes, animal care facilities and similar areas for deodorizing and general disinfecting of washable surfaces. This product is very effective when used at regular intervals to deodorize, sanitize and disinfect floors, walls, urinals, lavatories, telephones and similar surfaces and areas in need of sanitizing and cleaning.

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Use 3 ounces of product per gallon of water. At this dilution rate, the solution will be effective against *Pseudomonas aeruginosa* PDR-10, *Staphylococcus aureus* and *Salmonella choleraesuis*. This has been sustained by the A.O.A.C. Use dilution method.

**General Disinfection:** Apply solution with cloth, sponge or mop. Allow surfaces to remain wet for 10 minutes. Food processing surfaces, utensils, floors and walls, which are treated with this product, must be rinsed with potable water prior to re-use. At a rate of 6 ½ ounces of product per gallon of water, the product is effective against pathogenic fungus such as *Trichophyton interdigitale*. Use of this product to prevent and control athlete's foot in showers, dressing rooms, lockers, gyms, spas and similar areas is advised. For heavy soils or organic matter, a pre-cleaning step is required.

#### STORAGE & DISPOSAL

**Storage:** Do not expose product to temperature extremes. Store product in original shipping container in a locked storage area. Keep container closed when not in use. Do not contaminate water, food or feed by storage or disposal.

**Pesticide Disposal:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. In the event of a spill or leak, contain product with a dry absorbent and dispose of in accordance with state and local regulations. Wear protective clothing during clean up procedures.

**Container Disposal:** Triple rinse (or equivalent). Then offer for recycling, reconditioning or puncture and dispose of in a sanitary landfill or by other procedures approved by state and local authorities.
