DIRECTIONS

General Deodorizing: 1:60 with water. Apply with mop, sponge, sprayer or by emersing small articles. If possible, allow surface to dry without rinsing for maximum deodorizing action. Provides exceptional odor control in many areas including: garbage trucks, concrete floors, airplanes and buses, animal cages, packing plants, moldy air filters and carpets, hospital rooms, toilets and urinals.

Sewage Treatment Plants: Allow product to drip into incoming wastewater at the rate of 1 drop every 5 seconds. If odor still persists after 4 hours, increase dosage to 1 drop every 2 seconds.
