

m.a./SUB is a rapidly effective, low-odor, non-fuming, high sudsing acid base detergent for a variety of cleaning and descaling operations, this concentrated product may be used undiluted for severe encrustation of scale, mineral deposits, alkaline matter; or diluted with water for economical removal of hard water formations, soap scum, corrosion, lime build-up, or mortar spatters. This unique formulation combines with chemical strength of blended acids with the emulsification properties of high sudsing synthetic detergents. Cleans debris from brick and masonry surfaces, ceramic tile, mortar stone, and metallic surfaces other than aluminum or magnesium. **m.a./SUB** is ideal for cleaning, degreasing, and providing a light etch to concrete floors. Water conditioners assist in film-free rinsing of cleaned surface.

DIRECTIONS

For severe soil condition, dilute **m.a./SUB** with equal parts of water. Light soil accumulations may be removed with a dilution of one part **m.a./SUB** to 3 parts water. Adjust dilution to most appropriate concentration.

Apply to surface by mopping, spraying, brushing, or by immersion in solution. Allow surface to remain wet with solution for at least 5 minutes. Agitate if required for more even distribution of product. Rinse thoroughly with clear water and allow to dry. Repeat application procedure if necessary.

NOTE: Protective goggles, gloves, boots, and clothing should be used during **m.a./SUB** application for safety to personnel.
