PRECAUTIONARY STATEMENTS:

HAZARDS TO HUMANS AND DOMESTIC ANIMALS:

CAUTION: Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing vapors or spray mist. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling.

In food processing facilities, all benches, shelving, food contact surfaces, utensils, etc., must be washed with an effective cleaning compound followed by potable water rinse prior to use. Moths: Brush and air garments. Spray clothing, including under lapels, pleats, seams, keeping sprayer a foot away. Repeat in 30 days. **Bedbugs:** Spray sheets, blankets, pillows, both sides of mattress with special attention to tufts and seams. Dismantle bed, spraying joints, cracks, etc. Spray walls, baseboards and window trims. **Fleas on Cats and Dogs:** Spray lightly onto tips of animal's hair, or gently apply with a cloth, rubbing against grain of the hair. Spray kennel and bedding periodically. **Roaches, Waterbugs, Silverfish, Crickets, Spiders, Ticks, Centipedes and other crawling insects:** Apply on infested areas and on surfaces driving insects out for contact with killing mist. When possible, spray all cracks and crevices, under cabinets, sinks, around drains, floors and anyplace where insects crawl, nest or breed. Repeat weekly or as required to control. **Ants:** Spray along ant trails, into nests, on porch landings, building supports, foundations, or the sides of the house up to window level. Spray into all openings from which ants emerge. Repeat as required. **Flies, Mosquitoes, Gnats, Wasps, and Flying Insects:** Spray mist into corners, under furniture and upward into center of rooms, filling room with mist. Keep room closed for at least 10 minutes. **Poultry Mites:** Spray chicken houses, roosts, etc. Treat surfaces with wet coating. Repeat as needed.

STORAGE & DISPOSAL: Do not contaminate water, food or feed by storage or disposal. **STORAGE:** Do not expose product to heat, spark or open flame. Store container in a cool dry location. Do not expose product to temperature extremes. Store product in original shipping container in a locked storage area. Keep container closed when not in use. **PESTICIDE DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. In the event of a spill or leak, contain the product with a dry absorbant and dispose of in accordance with state or local regulations. Wear protective clothing during clean up procedures. **CONTAINER DISPOSAL:** Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill approved by state and local authorities.
