

NEGASHOCK is a scientifically formulated, anti-static compound that instantly eliminates static electricity generated by friction. Walking on carpeting or sliding across upholstered furniture or auto seats will not longer produce discomforting high voltage static sparks in low humidity settings. **NEGASHOCK** dries fast and is nonstaining. Protection usually lasts until the next shampooing or cleaning. Traffic lanes may need occasional retreatment.

NOTE: Always use **NEGASHOCK** at full strength. Do not dilute or add other chemicals. Do not use on wool or velvet fabrics. Always check an inconspicuous area for colorfastness. If product contacts furniture legs, wipe off with a clean damp cloth.

DIRECTIONS

Affix the trigger sprayer to the container as supplied. Adjust sprayer to deliver a light mist of **NEGASHOCK**. Apply to the carpet with a smooth even application from waist level. Allow the mist to float to the carpet. Do not oversaturate the surface to be treated. To treat plastic or vinyl surfaces, dampen a towel with **NEGASHOCK** and wipe surface. Wipe away excess material with a dry towel. Reapply **NEGASHOCK** after shampooing or cleaning.

NOTE: Do not confuse **GMP's NEGASHOCK** with products that look or claim to be the same. There is only one **NEGASHOCK**. With substitutes, you may sacrifice the high quality anti-static properties and nonstaining quality consistently available with **NEGASHOCK**.
