

**GMP CONCRETE ETCH RTU** is a liquid acid etch for surface preparation of unsealed concrete floors prior to applying a seal or finish. This solution neutralizes highly alkaline surfaces of concrete to insure a successful sealing job. This product opens the surface pores of concrete to permit proper adhesion of sealer and finish.

#### DIRECTIONS

All oil and grease must be removed with **GMP PUNCH**. Pre-wet the floor and apply **GMP CONCRETE ETCH RTU**. Always add this product to water on the floor; never add water to the product or potential for violent reaction exists. If there is no oil or grease on the floor, the solution will clean and etch the concrete.

Apply the solution by pouring it on the surface with a large sprinkling can and spread a liberal coating. Leave the product on for 10 to 15 minutes, then flush and rinse the surface to completely remove the solution and dirt.

**Container handling and storage:** Keep closure up to prevent leakage. Keep drum out of the sun and away from heat. Never use pressure to empty; the drum is not a pressure vessel. The drum must not be washed out or used for other purposes. Replace closure after each withdrawal. In case of spillage, flush with plenty of water.
