ODOR FRESH is highly concentrated, safe and always ready to use. This product requires no mixing. **ODOR FRESH** is non-corrosive and non-caustic, provides a continuous malodor control and residual activity.

ODOR FRESH is recommended for hotels, motels, restaurants, breweries, canneries, packing plants, slaughter houses, dog and cat kennels, incinerators, sewage plants, composts, garbage trucks and dumps, sugar refineries, rendering plants, dairies, and food processing plants.

DIRECTIONS

Use the canister to sprinkle **ODOR FRESH** over odor causing material, inside or outside. Use the refillable canister, or any convenient container, to carry bulk pack granules to source of odors.

General Use: For best results, sprinkle lightly into empty refuse and garbage receptacles. Add small amounts periodically or as refuse and wastes are deposited. This will prevent obnoxious odors from ever getting started.

Cigarette Urns: Use full strength or mix with sand or any other base material. This will not only keep the urn smelling clean, but will act as a room deodorant as well.

Sweeping: Mix with dry sweeping compound. Sprinkle on the floor and allow to stand a few minutes before usual sweeping.

ODOR FRESH may also be used without mixing with sweeping compounds in areas where treated dust mops are used.
