

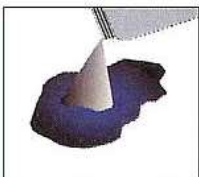

An environmentally friendly and natural product, it is produced from an inert naturally occurring rhyolitic volcanic ash, which is a naturally porous mineral that has unique absorption capabilities. In addition to petroleum-based liquids, **PETRO-GEL** is also capable of congealing other types of liquids including, but not limited to:

Oils	Body Fluids	Polymers
Solvents	Food Substances	Glycols
Paints	Vegetable Oils	Chemicals
Coolants	Herbicides	Acids
Greases	Insecticides	Pesticides

Because **PETRO-GEL** is non-leaching, it is suitable for disposal in landfills with no leaching effects. In addition, the product is non-biodegradable, non-toxic and non-carcinogenic and leaves no residue.

DIRECTIONS:

1. Completely cover spill with **GMP PETRO-GEL**. Work in immediately; do not leave **GMP PETRO-GEL** on spill, as this material is meant to be used immediately.
2. Work into the spill with a broom or shovel in all directions. Sweep back and forth until material darkens, and at that point the liquid has been completely absorbed. **GMP PETRO-GEL** will clean to a completely dry surface & remove residue from the top layer of surface.
3. After **GMP PETRO-GEL** has totally absorbed the spilled liquid, conveniently pick up with a dustpan or sweep into container for proper disposal.
