DIRECTIONS

On terrazzo, slate and quarry floors, it is recommended that this product be reduced 1 to 1 with water.

To remove **UITRA** from concrete, terrazzo, quarry or other similar surfaces, use a solvent-type or special water-based stripper. To remove from resilient floors or synthetic-type surfaces, use only a special water-based stripper. In all applications of the stripper, follow the manufacturer's directions and cautions.
